#### CALL TO ORDER

Dr. Allen called the meeting of the Harford County Public Library Board of Trustees to order at 6:30 PM.

# **CHANGES TO THE AGENDA**

There were no changes to the agenda.

#### **PRESENTATIONS/RECOGNITIONS**

Dr. Allen recognized and welcomed Councilwoman Boyle-Tsottles, present for her first Board meeting as the Harford County Council Liaison. Ms. Boyle-Tsottles shared her excitement for joining the Board as Council Liaison.

#### **APPROVAL OF MINUTES**

All Trustees had the opportunity to review the minutes of the previous meeting in advance of this evening's Board meeting.

MOTION: Motion by Mr. Adams, seconded by Colonel Vogelhut, US Army Retired, and carried by unanimous vote to approve the Minutes of the October 20, 2022 Board Meeting as presented.

#### **COMMITTEE REPORTS**

#### Budget & Finance Committee – Mr. Vido

The committee met on November 18, 2022 at 8:00AM and reviewed the proposed FY 2024 Operating and Capital Budgets. The committee recommended the proposed budgets as presented, while acknowledging that budget priorities may change with the new County administration. As an update on the Foundation's financials, Mr. Vido shared that this year's fall Gala raised approximately \$50,000.

The Treasurer's Report was prepared by Kathy Cogar, Chief Financial Officer. Operating expenditures for the fiscal period ending November 30, 2022 were within the annual FY2023 budget. Revenues were \$9.9 million and Expenditures were \$8.5 million. Expenditures for Contracted Services were over budget, year to date, as several annual contracts were paid in July/August - Polaris and Envisonware (Library software). It was noted that the library is experiencing the same supply chain and inflationary costs increases as everyone else and will be monitoring these expenses and modify the budget as needed.

# Executive Committee - Dr. Allen

The committee met on November 17, 2022 at 7:30AM. They reviewed the preliminary budget, committee reports, and health benefits. The committee also discussed review of the CEO's contract, which will be brought to the Board for review during the Executive Session. Dr. Allen noted that an update on the staff survey will be reviewed during the Executive Session.

# Capital Improvements Committee - Mr. Adams

The committee met on November 18, 2022 at 9:00AM and reviewed the proposed FY 2024 Capital Budget. The committee recommended the proposed budget as presented.

# Human Resources Committee - Ms. Wright

The committee met on November 21, 2022 at 8:00AM. The committee discussed the Board of Trustees Meet & Greets that took place in the fall and will continue. The committee also discussed the role of the Board at those sessions and how policy aligns with the role of the Board. The Board reviews existing policies on a regular basis and this will be ongoing. Sessions of the annual Coffee with the CEO have been scheduled. Maryland Libraries are working on legislation to enable collective bargaining for public library staff throughout the state. Dr. Allen noted that a draft preliminary report from the staff survey has been shared with the CEO. The Board is working hard to assess all the information from the meet & greets and Coffee with the CEO. The Board is working hard to assess all the information that is being shared and while this may take time to do it correctly, the end result will be valuable. Ms. Hastler clarified that sick leave may be used for mental health days.

# Foundation Board -Ms. Martin

The Foundation Board met and discussed the success of the recent Library Gala, as well as their plan to search for a new Foundation Director in the new year. Ms. Martin shared appreciation for those that worked together on Gala planning after some personnel changes. Additional information is included in the CEO report below.

# **CEO REPORT**

# **Building Projects**

**Administration** – A heat exchanger that services the Materials/Technical Services section of the building was not working. A call was placed to the County and a vendor came to evaluate. It was found that the heat exchanger was severely rusted and needed to be replaced. The County ordered the required parts which are expected to be in this week and then installed by December 16. If the project is delayed, we will relocate staff to other areas of the building until heat is restored.

**Bel Air** – The branch is the busiest branch in the system with approximately 27% of total activity (circulation, walk-ins, programming and attendance). It was last renovated/built in the mid- 1990s and is overdue for a refresh. The library is working with the county on a space assessment and exploring the possibility of incorporating some of the Administrative functions in the building. Library space planning prioritizes designing with flexibility and adaptability for future technology and needs. During this time of exploring options, the library will continue to maintain the appearance and functionality of the building to include small refresh projects in the meeting room, stairwells, and more. Meetings to begin the conversation of adapting the branch to include administrative functions began in February and continue. Colimore Architects completed a Bel Air Library Programming and Scope Study in early April 2021 and it is being reviewed with the county. The Library submitted a State Library Capital Grant proposal to offset some of the cost for fiscal year 2023 in the amount of a \$4,086,000 state grant request and total project amount \$8,513,000. Many thanks to the County Executive, Delegate Susan McComas, Senator Bob Cassilly, and Councilman Chad Shrodes for writing letters of support for the project. The County selected Murphy & Dittehafer Architects for the Schematic Design Phase which is in progress.

Both elevators will be replaced this fiscal year prior to the renovation project and many thanks to the County for coordinating the replacement. The project was presented to the County Board of Estimates for review on October 11, 2022. A pre-construction kick-off meeting was held November 17, 2022. Once the final paperwork is submitted to the county by the vendor, the notice to proceed (NTP) will be issued. Once the vendor has the NTP, the equipment will be ordered. Lead time to receive the equipment is 12-16 weeks. Estimated construction would then be March 2023 with 8 to 10 weeks to complete each elevator. If the branch closes to the public, both elevators could be done simultaneously and cut the time to renovate in half – one 8-10 week period instead of 16-20 weeks.

**Darlington Library** – The modular Darlington Library closed at the end of business on Saturday, September 17 in preparation for the move and opening of the new Darlington Library. The Library and County received the Use and Occupancy certificate on October 4<sup>th</sup> and quickly began moving into the new facility. Ribbon cutting and opening day took place on Wednesday, October 19, at 9:30 a.m., and well attended by the community as we celebrated the new resource. New staff have been hired and training underway. In addition, the collection was "unmasked" on October 19<sup>th</sup> so that holds may be placed and materials once again available for circulation. Some furnishings have been delayed and several items remain pending including the drive through window service. The recent heavy rains of the hurricane remnant caused major damage to the front walls/windows causing the two conference rooms to flood and substantially damaged the sheetrock. The damage was quickly assessed by the county and it was determined that the exterior stone was not installed correctly and was missing both caulk and a waterproof membrane. The county is working diligently to have the stone replaced by brick and appropriately installed. This correction has been completed and the front of the building is now complete. The County and the contractor continue to work on the remaining punch list items.

Delivery and installation of the branch furnishings and shelving end caps took place November 28 through November 30 and the "borrowed" items were returned to the lending branches. Punchlist items continue to be addressed.

**Fallston** - A maintenance bond inspection was held on October 18 coordinated by the County. Items of work to be completed prior to releasing the bond include filling in groundhog hole and overseed site to achieve minimum required turf grass coverage. In addition, screen trees will be planted in flat area below the library and the county will notify the library when the work is scheduled. The County is also working with a design engineer concerning dewatering of the facility.

<u>Dash Cams</u> – All Library vehicles are being fitted with front and rear dash cams. This was a recommendation made by employees who work on the outreach vehicles. Two cameras have been installed and installation for the remainder of the fleet is underway. Quotes have been received for a GPS system.

**Polaris Upgrade** 7.3 - Polaris ILS (Integrated Library System – catalog and more) is scheduled for a major upgrade on Tuesday, December 13. During the upgrade, the following will be offline and unavailable:

- Polaris, the online catalog and LEAP
- Databases and eResources
- Public computers, kiosks and access to accounts
- Printing, including contactless printing and printing from Envisonware/PrinterOn
- Some other services that use Polaris for authentication

Public WiFi, offline circulation, staff email and internet will be available.

# **Fines and Fees**

The Maryland General Assembly voted to override the Governor's veto of Building Lifelong Learners Act of 2020, on February 8th and will go into effect 30 days after the vote. The funding, to cover lost revenue, of an additional \$0.40 per capita pre-funding-formula, will not be in place until FY23.

There are three main points to the bill:

- 1. Not charging Overdue Fines The bill (as amended) states that "A Public Library may not charge a fine for overdue library materials on a minor's library materials." It further states, "A Public library may not attempt to collect any outstanding fees for overdue library materials that are incurred by a minor after June 30, 2021."
- 2. With regard to lost materials "A public library may not charge a fee for a minor's overdue library materials until 21 days after the date on which the library materials were due."
- 3. If materials are returned And "If a minor's overdue library materials are returned after a public library has charged a fee, the public library shall cancel the fee."

Special collections are specifically excluded in the bill (American Girl Dolls, cake pans, fishing rods, etc.) Minor is defined as under the age of 18.

Harford County Public Library is currently not charging overdue fines on any materials and will revise procedures to support the new legislation. The Library is working on reinstating overdue notices and bills as appropriate.

**HCPL Staff In-Service Day** – The Library's annual Staff Day was held on October 10<sup>th</sup> at Ripken Stadium, with the theme *Team HCPL Reunited*. The Aberdeen Ironbirds' General Manager, Jack Graham, spoke to the group on the topic *5 Guys on Either Side*. Library CEO Mary Hastler shared Library highlights and milestones in the state of the library presentation, and an all staff photo was taken on the baseball field.

More than 50 Library staff members were honored for years of service ranging from two to 30 years. The Roenna Fahrney Recognition Award, named in honor of Roenna Fahrney, library director from 1957-78, honors exceptional performance of staff members who demonstrate outstanding service to the community spirit. Individual Roenna Fahrney Award winners were Dianne Dacey, Aberdeen Library; George Pope, Havre de Grace Library; and Theresa Stephens, Bel Air Library. The Roenna Fahrney Group Award went to the Programming

Team, including Bridget Bloomer, Abingdon Library; Katie Troch, Whiteford Library; Julie Parsons, Bel Air Library; and Theresa Stephens, Bel Air Library. Congratulations to all!

# **Programming and Events**

Daycare providers were so excited to have in person visits once again by Opening the Gift! They saw a few children who had participated pre-pandemic, but for most children, this was a new experience. The crowd favorite was the call to do shadow dancing as the sun was at the perfect angle to reveal the different costume character outlines.

Edgewood celebrated DINOvember with a dinosaur themed scavenger hunt around the Children's Area. Prizes for finding all dinosaurs in the library was a tiny flexible T-rex, printed on the branch's 3D Printer. The Children's Area was also decorated with an excavation site bulletin board and activity table, along with the puppet theater having a dinosaur museum. Their Art & Stories program was also DINOvember themed, with children making their own dinosaur skeletons out of Q-tips.

Storytime families had a blast reading, singing and learning in pajamas during Havre de Grace's PJ Storytime. Kids enjoyed a bubble dance party and fun bathtub craft too.
